Statement of Significance

This item of clothing has historic and social significance because of its association with Prime Minister Tony Abbott. As the leader of the Liberal Party, and of the government of the day, Prime Minister Abbott is subject to daily scrutiny of his words and actions. His image is a crucial part of his presentation as a public figure and his selection of a silk Hermes tie indicates the importance he places in his appearance. Blue ties worn by members of the Liberal Party, including Tony Abbott when he was Opposition Leader, became the subject of a memorable speech by then Prime Minister Julia Gillard in 2013. In a speech to Labor fund-raising group 'Women for Gillard', Prime Minister Gillard said that a government dominated by "men in blue ties", meaning an Abbott government, would mean hard-won gains for women would be rolled back, specifically in relation to abortion laws. Her comments made headlines, with the Opposition accusing her of again playing the misogyny card . Thereafter, male politicians wearing blue ties became something of a byword for conservatism, particularly in relation to women's issues. This particular blue tie, then, is a strong symbol of a particular theme and conversation carried out in federal politics at a particular time.

History .

This blue silk Hermes the was worn by Prime Minister Tony Abbott for an unknown length of time. He is a habitual wearer of blue ties.

Anthony John Tony Abbott (b. 4 November 1957) became Australia s 28th Prime Minister on 18 September 2013. A member of the Liberal Party of Australia since the 1980s, Abbott was strongly identified as a conservative with traditional views on many social issues. Abbott was a Rhodes scholar at Oxford, and after considering a number of careers including the priesthood (reflective of his strong Catholic faith), eventually became a journalist and political adviser, before being elected to the House of Representatives in 1994 as Member for Warringah in Sydney s north. He was appointed to the ministry in 1998 by John Howard as Minister for Employment Services, in which capacity he spearheaded the creation of the Job Network, a scheme to find jobs for the unemployed, and administered the Work for the Dole Initiative. In 2001 he entered Cabinet as Minister for Employment and Workplace Relations and Leader of the House, and in 2003 became Minister for Health. Recognised as one of the most conservative members of the government, he was also known for his combative and aggressive parliamentary style. Upon the government s defeat in 2007, Abbott became Shadow Minister for Families, Community Services and Indigenous Affairs. He resigned this position in protest in late November 2009, at Liberal leader Malcolm Turnbull s decision to support an Emissions Trading Scheme. Abbott challenged Turnbull for the party leadership on 1 December and won by a single vote. In August 2010, the Coalition and Labor each won 72 seats in the House of Representatives; the Gillard Labor government continued in office after securing the support of key crossbench members. Abbott stepped up attacks on the government, labelling it illegitimate, and got considerable media attention and political traction after the implementation of the Clean Energy Bills of 2011, which produced the so-called carbon tax . Abbott s hard-line stance on asylum-seekers, characterised by the phrase stop the boats , also became a key issue at two successive elections. On 7 September 2013, Abboilt was elected Prime Minister after the Coalition won 90 seats in the House of Representatives.

This bicycle has historical, social and political significance because of its association with the donor, Australia's 28th Prime Minister, Tony Abbott. Tony Abbott has been associated with blke riding throughout his parllamentary career, and in 1998 was a founding organiser of the annual bike riding event Pollie Pedal. The political significance of the blke is closely linked to the event, as Pollie Pedal has a very high profile within parliament, involving a number of parliamentarians in it every year. The social significance of the blke arises from the fact that It was supplied to Tony Abbott for his Polile Pedal ride in 2009, and has been used by him ever since. It was custom made for him and has only been ridden by him and is therefore unique. It has both private and public significance for Tony Abbott, as he has also used cycling as a tool to remain fit and active. This blcycle was the one he chose to ride the day after he was elected Prime Minister, in September 2013, when his first action in the public eye was to go for an early morning bike ride.

Histony

This bicycle was custom made for Tony Abbott in 2009 by Australian company Hillbrick Bicycles, Hillbrick had been involved in the annual politicians' fundraising event, Pollie Pedal, since about 2005, supplying blkes and other gear to the riders. (CEO Paul Hillbrick, in conversation with Libby Stewart, 26/2/2015) In 2009 Tony Abbott was Opposition Shadow Minister for Families, Community Services and Indigenous Affairs. He took part in Pollie Pedal that year, a journey from Brisbane to Sydney which raised over \$100,000 for charity. Tony Abbott had been one of the founding organisers of Pollie Pedal in 1998 and has taken part ever since. Of the 2009 ride, the first he undertook on this Hillbrick blke, Abbott said 'This year's Pollie Pedal from Brisbane to Sydney was the longest and it was the hardest, but I would like to think that it was the best ride. It did not raise the most money of all of the Pollie Pedals but it did raise more than \$100,000 for a particularly good cause. I think that under the current economic circumstances that is not bad going.' (House of Representatives Hansard, 23 June 2009)

Anthony John Tony Abbott was first elected to the House of Representatives in 1994 after a career as a journalist and political staffer. He served as a junior minister in a variety of roles before being appointed to Cabinet as Minister for Employment and Workplace Relations in 2001. In this role he oversaw the creation of the Job Network employment scheme. Appointed Health minister in 2003, Abbott became known for his rough, robust parliamentary style. In 2009, in opposition, he replaced Malcolm Turnbull as Liberal leader and led the Coalition to the 2010 election, which resulted in a hung parliament, with Labor and the Coalition tied at 72 seats each. On 7 September 2013, Abbott was elected Prime Minister after the Coalition won 90 seats in the House of Representatives.

Of the reason for his cycling habit Abbott has said 'Well it was the Pollie Pedal - my annual charity bike ride - which initially got me onto the bike and into lycra but after a few years it became a key part of my fitness regime. It also doubles as a good way of staying in touch with people given that some of my very best friends from uni days have all become quite keen cyclists. So it s the companionship as much as the fitness.' (Chris Pash, 'THE NEW GOLF: Tony Abbott And 8 CEOs Tell Us Why They Love Cycling', in Business Insider Australia, 3 April 2014) Tony Abbott kept the Hillbrick bike in his Canberra office, while he has a different brand of bicycle at his home in Sydney. He did use the Hillbrick bike, though, on the morning after he was elected Prime Minister in 2013 to go for an early morning ride from his Sydney home. This ride was reported nationally and internationally with Abbott quoted as saying "'It was great to start the day with a ride with the people I've been riding with for years," before being driven to his office.
